Re:

Food Stamp Program - 10/1/2002 Cost-of-Living Increases

Overview

State Letter 1236 issues policy revisions implementing the following cost-of-living changes in the Food Stamp Program, effective 10/1/2002:

Maximum Benefit Allotments - The maximum benefit levels for all assistance unit (AU) sizes have increased (see Attachment A).

Gross, Net and 165 Percent Income Eligibility Standards - The Gross, Net and 165 Percent Income Eligibility Standards have increased (see Attachment A).

Shelter Deduction - The Maximum Shelter Deduction increased to \$367.

Standard Deduction - The Standard Deduction has been replaced with a deduction that varies according to AU size. This deduction will be adjusted annually for cost-of-living increases. No AU will receive a deduction less than the old standard or more than a deduction for an AU size of 6.

Overview (Continued)

Standard Utility Allowances - The SUAs remain the same.

- the heating standard utility allowance (SUA) remains at \$391.
- the nonheating SUA remains at \$237.
- the telephone SUA remains at \$28.

Homeless Shelter/Utility Deduction - The Homeless Shelter/Utility Deduction remains at \$143.

Automatic **Food Stamp** AUs

All active food stamp AUs on BEACON as of the close of business on Update of Active 9/20/02, will be automatically recalculated using the increased standards.

> • Food stamp AUs with an increased food stamp benefit amount will be automatically authorized. The newly calculated benefit amount will be displayed on the Active by Grantee Name view.

Report of **Updated AUs**

A report "Food Stamp 10/2002 COLA Updated AUs" will:

- be available on ViewDirect during the week of 9/23/02;
- list all the AUs automatically increased as a result of the COLA;
- list the AU's old and new food stamp benefit amounts (as adjusted by the system); list the amount added to the 10/2002 issuance (benefits owed from 10/1/2002 to 10/2002 cyclical date); and
- be used for reference.

Recipient Notice AUs listed on the "Food Stamp 10/2002 COLA Updated AUs" report will be sent the following notices:

- an English/Spanish notice (Attachment B); and
- a multilingual notice that states, "Important! Please have this notice translated immediately."

AUs With Decreased Food Stamp Benefit Amounts

Food Stamp AUs with decreased food stamp benefit amounts will not be automatically authorized. They will appear on the Interview Wrap-up, Pending Release view and will require review. AU Managers must:

review each AU based upon release date, starting with the earliest release date; and

AUs With Decreased Food Stamp Benefit Amounts (Continued)

• allow the decrease to be authorized if appropriate; or delete the action pending to be released, if it is determined that the decrease is erroneous.

Note: If, after reviewing the AU, it is determined that the decrease is erroneous, take appropriate action.

When to Use New Standards

AUs authorized on or after 9/23/2002 will have benefits calculated using the 10/1/2002 issuance standards.

Closed Food Stamp AUs

Closed food stamp AUs owed additional benefits for the 10/2002 COLA will be issued benefits. These closed AUs will:

- have benefits dated and issued in mid-October 2002;
- be listed on the "Assistance Unit List, Closed/Denied Within the Last Two Months view.

Note: A "Last Paid" date and a "Benefit" amount column were added to show which AUs received a prorated food stamp benefit amount for the period between 10/1/2002 and the AU's cyclical start date for October;

- be sent an English/Spanish notice (Attachment C); and
- a multilingual card that states "Important! Please have this notice translated immediately."
