From the Commissioner

Dear Colleagues,

As I mentioned in my December *Transitions* letter, family homelessness in Massachusetts is on the rise. With shelters at capacity, we currently have more than 600 families temporarily housed in hotels. Reducing homelessness and eliminating hotel usage is a high priority for the Patrick/Murray Administration and the Department has worked tirelessly to help homeless families across the Commonwealth. We have implemented many new initiatives and partnerships over the past few months but unfortunately, the number of families in need continues to grow.

Each week, we have participated in meetings with representatives from the Interagency Council on Housing and Homelessness (ICHH), the Department of Housing and Community Development (DHCD), the Executive Office of Health and Human Services (EOHHS), the Executive Office of Housing and Economic Development (EOHED) and the Lieutenant Governor's Office to develop strategies to stem the tide of family homelessness. Together, we determined that a comprehensive reform of the housing and shelter systems with a focus on "Housing First" is necessary to reduce homelessness in the Commonwealth.

A major step in this reform is to bring together the emergency shelter system and the housing production delivery system by integrating the Department of Transitional Assistance's (DTA) individual and family emergency shelter programs into DHCD. Combining housing and shelter will create a single point of entry, assessment, and access to housing solutions for individuals and families who are already homeless or who are at-risk of losing their housing. The consolidation will also provide an expanded array of prevention and diversion resources and inform the housing production agenda by identifying specific housing supply needs. This effort will carry out the recommendations of the Commission to End Homelessness and will also make it easier to identify and address gaps in services available to extremely low-income households. The Administration's acknowledgement that this structural re-alignment is necessary underscores the fact that homelessness is a housing problem.

Governor Patrick will file legislation under Article 87 of the State Constitution in the upcoming weeks to finalize this reorganization, which will become law in 60 days unless disapproved by either of the branches of the Legislature, and would be effective as of July I, 2009. Over the next few months, DTA and DHCD will continue to work together to get feedback on the reorganization and to ensure a smooth transition for both our staff and the families we serve.

This initiative will impact DTA staff members who work in the Housing and Homeless Services Unit and certain local office field staff. Although the specifics will be negotiated with Local 509 and NAGE, it is anticipated that these staff members will be transferred to DHCD.

I am confident that the knowledge and experience of our dedicated colleagues will be a tremendous asset to this new initiative. It is important to note that the programmatic changes to the emergency housing response system do not reflect and are not driven by a plan to reduce staff. Each of our colleagues who is directly involved in the shelter delivery system will be part of an extraordinary effort to accelerate housing placements with support services and reduce reliance on emergency shelter.

This is a great change and we will do everything we can to ensure that the transition is as seamless as possible. Please note that DTA will continue to offer nutrition assistance, cash assistance, and employment supports to homeless families and we remain committed to working with DHCD to coordinate resources and supports in order to comprehensively assist extremely low-income families and individuals to move out of poverty.

As always, thank you for your hard work and perseverance during this challenging time. With your commitment and dedication, each day we are able to make strides toward meeting our mission to assist low-income individuals and families to meet their basic needs, increase their incomes, and improve their quality of life.

Quality Corner

The two errors we will review this month occurred in Non-Public Assistance (NPA) SNAP cases. The error in the first case was caused by self-employment income while the error in the second case was related to household composition.

Self-employment Income and Change Reporting

This NPA SNAP household consisted of a husband and wife and their four children. The only reported income was the husband's self-employment as a taxi driver. The case manager correctly used the household's income tax return to determine the monthly self-employment income but then incorrectly put the case on Universal Semiannual Reporting (USR).

At the time of the QC review, the client reported that she had started to receive rental income of \$950 per month. As a USR case, the additional income would not have caused the case to close and so would not have to be reported. However, had this household not been established as USR, the client would have been required to report the new rental income to the case manager within 10 days. Since this household should have been established as a change reporting household, QC recalculated the monthly SNAP benefits using the rental income. This caused a large overissuance.

What's a Case Manager to Do?

At the time of the last recertification, the case manager incorrectly placed the household on USR. Therefore, the client may not have reported the rental income because she knew it would not have caused her household income to exceed the gross limit for household size.

Since the SNAP household included a member who was self-employed, the household should have been

placed on change reporting (see 106 CMR 366.110 (C)(1)). This case would have received the correct SNAP benefits if the case had been correctly established as a change reporter at the time of certification and if the client had timely reported the new rental income. Remember, even if one person in the household is employed but another member is self-employed, the household must not be put on as USR.

Reported Change in Household Composition

This was a combined TAFDC/SNAP household that included a mother on TAFDC, two children on SSI and an older daughter and her two children. The daughter with the two children reported to her case manager that she and her children had moved out of her mother's home. The case manager had removed them from the SNAP household on the AU Composition Results window but had failed to make them Not Present on the Household window so the three former household members continued to be included in the SNAP benefits. This caused a large overissuance for the review month

What's a Case Manager to Do?

When a household member moves out of the household, the case manager must remember to remove the household member by going to the Household window and indicating that the member is Not Present. The case manager must then go to the AU Composition Results window to close the household member from the SNAP household. Case managers may also check the EBC calculation after entering an action that results in a change in benefits. The new benefit amount would indicate whether or not the action had been correctly processed. EEC Policy Change for DTA Families Accessing Homeless Child Care Assistance

Field Operations Memo 2008-63

Effective November 3, 2008, the Department of Early Education and Care (EEC) changed its policy which affects the provision of homeless child care assistance for DTA homeless families living in shelters, hotels and motels. The policy change limits homeless child care assistance to **3 months**. At the end of the 3-month period, the Child Care Resource and Referral (CCR&R) agency will reassess the family's eligibility for continued child care not related to homelessness, including eligibility for Department of Children and Families (DCF) supportive child care, where appropriate, as well as eligibility based on EEC income and activity requirements.

This Field Operations Memo:

- informs DTA staff about the EEC policy change that affects homeless child care assistance for eligible DTA homeless families; and
- reminds DTA staff about the importance of providing a current BEACON-generated Child Care Referral notice to a family and/or to the Child Care Resource and Referral (CCR&R) agency, when appropriate.

Changes to Sponsor Deeming Requirements for TAFDC, EAEDC and SNAP (PA and NPA) Households

All Field Operations Memo 2008-65 State Letter 1344

This memo:

- reviews changes to sponsor deeming requirements;
- provides instructions for processing households not subject to sponsor deeming at application;
- provides instructions for processing households not subject to sponsor deeming at recertification/eligibility review; and
- discusses the handling of SNAP households still subject to sponsor deeming provisions.

State Letter 1344 rescinded the noncitizen sponsor deeming regulations for TAFDC. The Department no longer considers a sponsor's income and assets when determining sponsored noncitizen eligibility.

The noncitizen sponsor deeming regulations for SNAP have been revised. The rules for processing and counting sponsor income and assets have been simplified. In addition, only non-categorically eligible SNAP households will be subject to noncitizen sponsor deeming. These regulatory changes became effective December 15, 2008.

2009 Social Security/SSI COLA for TAFDC, EAEDC and SNAP

Field Operations Memo 2008-68

The Social Security and SSI Cost-of-Living Adjustments (COLA) have been scheduled. Effective January 2009, Social Security benefits and SSI payments will increase by 5.8 percent. The basic Medicare Part B premium will remain unchanged at \$96.40 per month.

- general BEACON activities for processing the 2009 Social Security/SSI COLA; and
- case manager and supervisor activities required to prepare for the 2009 Social Security/SSI COLA.

During the first two weeks of January 2009, the Department will issue the annual informational mailing about federal and state tax credits and child care assistance. Included with this mailing, the Department will take the opportunity to inform clients and certain former clients about a TAFDC work program requirement change and the Food Stamp Program name change to SNAP.

The mailing will be sent to all active TAFDC clients, all former TAFDC clients whose cases closed on or after January 1, 2008, and all active SNAP cases, excluding SNAP cases in the Malden Centralized SSI Office and SNAP cases receiving TAFDC.

Supplemental Nutrition Assistance Program (SNAP): Replacement of Food lost Due to 12/11/2008 Ice Storm

Field Operations Memo 2008-73, 2008-73A

As a result of the ice storm that occurred on December 11, 2008, a number of communities in central and western Massachusetts were without electricity for a number of days. The Massachusetts Emergency Management Agency (MEMA) designated 119 cities and towns as being affected by this power outage. To alleviate any hardship suffered by SNAP households living in these areas, the Department requested and received a waiver from the United States Department of Agriculture (USDA) to automatically replace 50% of certain household's December SNAP benefits. These replacement benefits were issued on December 20, 2008. This memo explains the process by which the replacement was done and identifies the communities where the replacement benefits were issued. USDA granted a waiver allowing households not in receipt of the automated replacement benefits additional time to request replacement benefits based on the SNAP household misfortune rules. The new deadline for these claims was December 29. 2008.

Housing Opportunities for EA Families

Field Operations Memo 2008-74

This Field Operations Memo reminds case managers, homeless coordinators, shelter providers, and housing search providers how important it is to fully explain the housing search responsibilities to the EA family.

Responsibilities include:

- cooperating in the housing application process if the Housing Solutions Team Command Center (HSTCC) team finds a unit for the EA family;
- appealing a management company's decision to deny the EA family's application;
- applying for public housing at all housing authorities within 20 miles of the EA family's home community,
 unless there is a domestic violence or other safety issue;
- withdrawing any public housing application that is beyond 20 miles of the family's home community, unless the family would accept the housing; and
- removing the EA family's name from all other waiting lists when the family is permanently housed using a Section 8 subsidy or MBHP voucher.

Do you know...?

The Toy-Drive Committee from the Housing and Homeless Unit, with help from other units in Central Office, local TAOs, DPH and other state agencies, Mass Coalition for the Homeless, and some very generous shelter providers worked together to collect approximately 1300 presents and gift cards for the 640 homeless families who were in hotels this holiday season. Even family members and train-commuting friends supported this effort with donations and a huge assortment of hand-knitted hats for older girls. To list the names of everyone who offered their time, money and brawn to wrap and deliver these gifts would be impossible. The housing staff is very grateful to all who gave their support in making sure no child in a hotel went without a present or two this holiday season.

By all reports, this very extensive effort was greatly appreciated and each present warmly received.
