Re:	SNAP – ABAWD Work Program Updates				
Overview	This Transmittal advises staff of a number of clarifications to the ABAWD Work Program Requirement, including several BEACON and forms changes. To convey these clarifications, a number of pages have been updated in the ABAWD chapter of the Online Guide.				
Summary	 This Online Guide update transmits the following changes effective with BEACON Build 48.3, scheduled to be implemented 4/4/16: Cooperating is no longer a selectable removal reason for ABAWD Work Program Requirement sanctions. When an ABAWD Work Program Requirement sanction is removed for Good Cause, the Work Requirements-FS page is automatically updated to display the Good Cause status and end date.

Summary (continued)	• A new Job title: ABAWD Unpaid Work is available for selection from the Job title drop-down list when entering an employment record on the Earned Income page.
	• The exemption reason: Refugee Training Program Participant was added to the Required status reason drop-down list on the Work Requirements- FS page.
	• Two new Required status reasons: ABAWD WP-0 CS hours and ABAWD Work Program-Sanctioned may be assigned to non-exempt ABAWDs.
	 A non-exempt ABAWD's monthly community service obligation now displays on the Work Requirements-FS page. The date of the most recent ABAWD Work Program Community Service Participation Report is displayed when applicable. When a participation report was not issued, the reason that it was not issued is displayed: Not Required working 20 hrs/wk; Not Required qualifying E and T activity; or Not Required Good Cause.
	• The new ABAWD Clock History Popup page is now accessible via the SUM icon on the Work Requirements-FS page.

- Minor changes were made to ABAWD notices to increase readability.
- A Calculate button was added to the Work Requirements- FS page to aid case managers in determining if the exemption reason Unfit for Employment based on screening can be applied to a homeless ABAWD based on his/her answers to the screening questions.
