TAFDC - Clothing Allowance, September 2011

Overview

The Department will issue a nonrecurring clothing allowance of \$150 per eligible TAFDC client under the age of 19 for September 2011. This Operations Memo is being reissued to correct dates found on page 3.

Who is Eligible

All TAFDC clients under age 19 who are active on September 1, 2011 or TAFDC-eligible during the month of September 2011 are eligible for a clothing allowance. The clothing allowance is prorated for clients under the age of 19 with an eligibility start date after September 1, 2011. A child born after the family cap date is ineligible for a clothing allowance, unless a waiver or exception of the family cap rule has been granted by September 30, 2011.

Amount

A separate payment is issued for:

- \$150 per eligible client under age 19 on September 1, 2011; or
- a prorated amount per eligible client under age 19, if eligible for part of September 2011.

Clients receiving payments through direct deposit will have the clothing allowance deposited into their bank account.

Clients receiving payments through EBT will have the clothing allowance deposited into their EBT account.

Increased Standards

Refer to the mass.gov/dta website, and select the Program Eligibility Charts and Tables link under Key Resources to view the Eligibility, Need and Payment Standards for the month of September.

Eligibility standards are increased by \$277.50, and Need and Payment standards are increased by \$150 for each eligible applicant and client under age 19.

In October 2011, the standards will return to the regular amounts. BEACON will recalculate eligibility and send notices to clients no longer eligible for TAFDC benefits.

September Applications

BEACON will perform an eligibility test for all applicants who are approved for TAFDC after September 1, 2011 using the lower August 2011 eligibility standards. If the applicant is ineligible using the lower standards, BEACON will perform a second test of eligibility using the higher September 2011 standards. If the applicant passes this second test, BEACON will issue a payment for a portion of the \$150 amount per eligible client under age 19.

The following informational message will appear on the Interview Wrapup EBC Results pages for these cases:

"This AU is not eligible for TAFDC using the regular Standard of Need, but is eligible for a Clothing Allowance in the amount of \$XXX.XX."

Payment Dates

The clothing allowance payment will be available to clients according to the following chart:

Payment Dates (continued)

Supplemental payments will be available on September 16, October 14, November 18 and December 16 (notices should arrive on or about those dates) to households with eligible clients under age 19 who become eligible during the month of September 2011 and are approved on the dates in the chart below:

For clients who become eligible during September and are approved between (these dates have been changed from Operations Memo 2011-40):	the supplemental clothing allowance will be available on:
Sept 1 – Sept 13	Sept 16
Sept 14 – Oct 11	Oct 14
Oct 12 – Nov 15	Nov 18
Nov 16 – Dec 13	Dec 16

These clients may receive a full or prorated amount of the clothing allowance, depending on the date of application or eligibility. The date and amount of the clothing allowance may be found by accessing the Benefit History tab on BEACON for the appropriate case.

Notices

For clients eligible on September 1, notices (Attachment A) will be sent in August.

A notice will be sent in September, October, November, and December to households with eligible clients under 19 years old who become eligible during the month of September 2011 and who will receive a full or prorated amount of the clothing allowance on either September 16, October 14, November 18 or December 16.

AN IMPORTANT NOTICE ABOUT A CLOTHING ALLOWANCE PAYMENT

Dear Mary Jones:

A clothing allowance will be paid for September 2011 for TAFDC. The clothing allowance is \$150.00 for each eligible person under 19 years old.

Your clothing allowance payment for September is in the amount of \$300.00 for 2 persons under 19 years of age.

This is a one-time payment which will be transferred into your bank account or EBT card no later than September 3rd.

For additional resources, you may also find it helpful to contact the Mass 2-1-1 Call Center. This is a statewide phone-based information and referral system. The Mass 2-1-1 Call Center information and referral line is free and confidential. This service is available 24 hours a day, seven days a week. By calling 2-1-1, callers are connected to a trained specialist who can provide information about critical health and human services available in your community.

If you have trouble reading or understanding this notice, you may call Recipient Services at 1-800-445-6604.

If you do not agree with the amount of your clothing allowance payment, you may request a fair hearing by filing an appeal within 90 days of receiving the clothing allowance payment. The reverse side of this notice contains important information about your hearing rights. To request a hearing, complete the reverse side of one copy of this notice.
