


School Employment - Wage Exclusion Instructions

If there is a reasonable assurance a claimant with school employment in the base period will return to the same or a similar position in the next academic year or term or at the end of a customary vacation period, base period wages earned in that position or a similar position will be excluded from the monetary calculation used to establish a Weekly Benefit Amount for the week(s) the claimant is on "break". The fact finding must include details of positions and dates worked for all base period employers who have been identified as school employers. The wage exclusion can be all of the wages or some of the wages earned and in the base period quarters.










