Custodial Parent Notice from DOR - TAFDC

Purpose of Memo

This memo informs TAO staff that DOR has developed a new notice that is sent monthly to current and former TAFDC recipients telling them about the child support collected in the previous month.

Who Gets This Notice

DOR is sending the *Custodial Parent Notice of Child Support Collection For XXXX*, Attachment A, to current TAFDC recipients and former TAFDC recipients with assigned arrears, but only if DOR has collected (and disbursed) support in the prior month. The notice shows the total collected, broken down by noncustodial parent (there may be more than one noncustodial parent), the amounts applied to current obligations and arrears, and the amount paid to the family. Please note that this notice does not specify any amounts retained by the Commonwealth to reimburse public assistance, and does not reflect any DEFRA payments (passthrough payments) made by DTA.

The first copies of this notice were sent to about 23,000 current and former TAFDC recipients at the end of December, 2003 and contained collections information for November, 2003. December notices went out the week of January 12, 2004. Starting in February 2004, notices for the previous month will be run over the first full weekend of each month, (i.e., notices about January collections will go in the mail starting Monday, February 9).

CUSTODIAL PARENT NOTICE OF CHILD SUPPORT COLLECTION FOR

Dear :

The Child Support Enforcement Division of the Massachusetts Department of Revenue (DOR) collects and distributes child support for your family. This notice tells you how much child support DOR collected on your behalf from your child's other parent for the period stated above and how much of the amount collected was paid to you.

Our records show that all or part of your support rights are assigned to the Department of Transitional Assistance (DTA). This is because you receive public assistance now or received public assistance in the past. This means the state may be required to keep all or part of the support collected as repayment for the assistance you and your children received.

If the amount of support collected is greater than the amount that DOR paid to you, all or part of the collection may have been applied to repaying public assistance, repaying payments sent to you in error or penalties and fees retained by the state. Please note that DOR is required to hold certain kinds of collections, such as tax refund intercepts and bank levies, in order to give the other parent time to appeal before we send the collection to you. Amounts that we are holding are not shown on this notice, but will be shown on a future notice once any amounts on hold are distributed to your case. If the amount that DOR paid to you is greater than the amount collected in this month, the amount paid to you may include amounts collected in a prior month.
