Re: TAFDC – Clothing Allowance, September 2015

Overview

The Department will issue a nonrecurring clothing allowance of \$200 per eligible TAFDC client under the age of 19 for September 2015.

**Purpose** 

This Online Guide Transmittal advises DTA staff about:

- who is eligible;
- payment amounts;
- payment dates;
- notices; and
- revised and new Online Guide pages.

Who is Eligible and Payment Amounts A payment of \$200 (separate from the semi-monthly payment) will be issued for TAFDC clients under age 19 on August 29, 2015 if they are eligible effective September 1, 2015. If a client becomes eligible effective September 1 at a later date, he or she will receive a supplemental payment on one of the dates listed on the next page.

TAFDC clients under age 19 will receive a prorated amount if they become eligible after September 1, 2015. These clients will receive a supplemental payment on one of the dates listed on the next page.

### Payment Dates

For clients eligible on September 1, all clothing allowance payments will become available to clients on August 29, 2015, whether they receive benefits through direct deposit or EBT.

Supplemental payments will be available on September 18, October 23, November 20 and December 18 to households with eligible clients under age 19 who become eligible during the month of September 2015 and are approved on the dates in the chart below:
