Clarification of DOR/CSE Procedures

Online Guide Transmittal 2019-43

Only out-of-state records, Cooperation with DOR Notice (DOR-CN) and Mother's Affidavits must be mailed to the DOR/CSE Liaison contact. When a client reports the possibility of one or more individuals as the absent parent, only add one absent parent record at a time for that dependent child. When making changes to the absent parent window, the interview wrap-up needs to be completed to ensure that DOR/CSE receives the updates timely.
