3 Your landlord should give you <u>discovery</u> by February 18, 2023. File a <u>motion to</u> <u>compel discovery</u> if needed on February 23, 2023

Get ready for court and show up on TBD. Because of the Covid-19 emergency, your court date may change. Call the court to be sure.





Filing for free

The court may charge you a fee to file these forms.

The cost can include:

- \$0.00 to get an emergency order, and
- \$195.00 to file the case in court.

But most tenants do not pay anything. You can file for free if:

1. You earn less than 125% of the Federal Poverty Level for Massachusetts, or

- 2. You get certain benefits, like Mass Health, or
- 3. You cannot afford to pay the fee.






