Because of a change in your Social Security income, on 02/07/2025, your Supplemental Nutrition Assistance Program (SNAP) benefits will go from \$105 to \$95. The new amount may also be the result of a change in your other income, expenses, or a change in the number of household members.

Your SNAP may go up if you tell us about certain costs. For example:

- If you or someone you get SNAP with is 60 or older or disabled, tell us about medical costs over \$35 per month.
- If you are working, looking for work, or in school, tell us if you have expenses for child care or the care of a disabled adult.
