ACTIVE CASES WITH LANGUAGE CODE 3 - OTHER REPORT

Overview

In January, local offices will receive a report entitled Active Cases With Language Code 3 - Other. This report was developed to assist the Department in implementing an agreement with the Office of Civil Rights (OCR) to ensure that all category 0, 2, 4 and 9 cases are coded on PACES with the correct language code. This report displays two key fields, PID Field 34 Language Code and New Language that must be used to record data, if appropriate.

Report Summary

The Active Cases With Language Code 3 - Other Report displays cases that are currently identified on PACES with language code 3 (primary language is other than English, Spanish or listed language). All language codes are displayed in Appendix B of the Systems User's Guide, Volume 1, PACES. To implement the agreement with OCR, each client's primary language must be determined and the language code entered on PACES. When recoding a case, use the report as the data entry document and enter the language code in the report column titled PID Field 34 Lang Code. Each local office will receive three copies of the report which displays cases specific only to that office. The report is sorted by LWO, CAN and alpha within CAN. Totals are displayed for CAN and LWO. The pagebreak is by CAN.

Local Office Responsibilities Local office staff must review each case listed on the report and determine whether or not the primary language of the recipient is known and if there is a valid PACES language code to identify the language.

If a language can be identified and the language code is displayed in the <u>PACES User's Guide</u>, enter the appropriate code on the report and submit the report to the data entry unit.

If a language can be identified and the language code is not displayed in the <u>PACES User's Guide</u>, print the language in the field titled New Lang on the report.

If the language cannot be determined, contact the client and schedule an appointment for the client to review and sign the "I Speak" card.

- If the client checks a block displayed on the "I Speak" card, enter the appropriate language code on the report and submit the report to the data entry unit.
- If the client does not, check a block displayed on the "I Speak" card because the language is not displayed, print the language in the field titled New Lang on the report.

After all cases have been reviewed, submit the report to the Assistant Director. The Assistant Director must review the report and ensure that all cases have been reviewed and acted upon. The report must then be submitted to Peter Boyle of Field and Eligibility Operations in Central Office by the end of January. Arrangements will be made with appropriate staff to add the new language code to the <u>PACES User's Guide</u> and the "I Speak" card.

Data Element Description

The following data elements are contained on the report:

CAN

The case assignment number of the worker responsible for the case

Cat

The category of assistance of the grantee or head of household

SSN

The social security number or facsimile number of the grantee or head of household

St

The status of the case

Name

The name of the grantee or head of household

Address

The street address of the grantee or head of household

City

The city or town in which the grantee or head of household resides

State

The state in which the grantee or head of household resides

ZIP

The zip code for the city or town in which the grantee or head of household resides

PID Field 30 Type

Make no entry. Type Code E is preprinted on the report.

PID Field 34 Lang Code

Enter the appropriate PACES Language Code.

The PACES Language Codes are:

- 3 Other (other than a listed primary language)
- 4 Armenian
- 5 Cambodian
