Overview

Since the release of 2024-20 Interim Disability procedures for EAEDC and SNAP on 3/14/24, additional clarification and a correction is needed regarding the requirement for certain Emergency Aid to the Elderly, Disabled, and Children (EAEDC) clients to sign the Authorization for Reimbursement of Interim Assistance (AP-SSI-IAR) form. The Department has also become aware of changes to the Supplemental Security Income application process.

**Purpose** 

The purpose of this Online Guide Transmittal is to inform staff of updated guidance on:

- clarification of which EAEDC clients are required to sign the AP-SSI-IAR form,
- clarification of which clients must apply for SSI, and
- updates to the Social Security Administration website, that now allows clients to apply for SSI online rather than just request an appointment to apply.
