Re: TAFDC – Clothing Allowance, September 2024

Overview

The Department will issue a nonrecurring clothing allowance to eligible TAFDC clients under the age of 19 for September 2024. This year the amount of this benefit is \$500 per eligible TAFDC client. Children who do not receive TAFDC are not eligible for this benefit.

Purpose

Who is Eliqible & **Payment Amounts**

A payment of \$500 (separate from the semi-monthly payment) will be issued for each TAFDC eligible client under age 19 effective August 30, 2024. If a client under age 19 becomes eligible between September 1, 2024, and September 30, 2024, a supplemental payment of \$500 per eligible child will be issued at a later date.

Payment Dates

For clients who are eligible on September 1st, all clothing allowance payments are expected to be available to clients on August 30, 2024.

For clients who become eligible during the month of September 2024, supplemental payments are expected to be available on September 20th, October 18th, November 22nd and December 20th. Clients will be sent a notice informing them of the clothing allowance and their amount.

Sept 18 th – Oct 15 th	Oct 18 th
Oct 16 th – Nov 19 th	Nov 22 nd
Nov 20 th – Dec 17 th	Dec 20 th

Planned for early August 2024, the following text message and DTA Connect Communication alert will notify the above-mentioned clients of the clothing allowance.

> "Your household is getting a TAFDC clothing allowance this year. Check your balance on DTA Connect."

These text messages and DTA alerts will be sent in English, Spanish, Portuguese, Haitian Creole, Vietnamese, and Chinese based on the language on file. Those with Heightened Level of Security (HLS) or who have affirmatively opted-out of text messaging and alerts from DTA will be excluded. Text messages are sent regardless of the phone type listed on BEACON.
