Re: SNAP: Cost-of-Living Changes

Overview

The annual SNAP COLA was processed during the weekend of September 22, 2012. This is a mass change affecting the entire SNAP caseload. The recalculation will impact the household's monthly benefit for October.

The following elements of the COLA will change effective October 1, 2012.

- **Shelter Deduction** The maximum shelter deduction (for households without an elderly or disabled member) **has increased to \$469**.
- Standard Deduction has increased for all Household Sizes

#### • Standard Utility Allowances (SUAs)

- The Heating/Cooling SUA has decreased to \$586;
- The Nonheating SUA has decreased to \$360;
- The Phone SUA has decreased to \$41; and
- The Bay State CAP SUA has decreased to 586.

### Overview (continued)

#### **Unchanged COLA Standards**

- **Maximum Benefit Levels** The maximum SNAP benefit levels for all household sizes remain unchanged.
- **Minimum Benefit Level** The minimum benefit level for eligible oneand two-person households remains at **\$16**.
- **Homeless Shelter/Utility Deduction** The Homeless Shelter/Utility Deduction remains at \$143.

## Impact of COLA on SNAP Benefits

Recalculation results indicate that some SNAP households:

- Will be negatively impacted by the decrease of the heating/cooling SUA and the nonheating SUA;
- will receive a small increase in SNAP benefits; or
- will remain at the same SNAP benefit amount.

#### Recipient Services To Handle COLA Calls

To alleviate the burden a surge in call volume could place on TAOs, the COLA notices do not include case managers' phone numbers. Instead, Recipient Services staff at Central Office will handle COLA-related calls.

#### Automatic Update of Active SNAP Households

During the weekend of September 22, 2012, active SNAP cases on BEACON, including Bay State CAP, were automatically recalculated using the new COLA standards. SNAP cases with a decrease in benefit amount are displayed on the Active by Grantee Name view under Assistance Unit Lists.

#### Report of Updated Households

A report entitled "Food Stamp 10/2012 COLA Updated Case":

- will be available on View Direct, Report ID:DTA 9023 on September 25, 2012;
- lists all households that have experienced a change in benefit amount as a result of the COLA;
- lists the household's old and new SNAP benefit amounts (as adjusted by the system); and
- can be used for reference by TAO staff.

#### Client Notices

A notice will be sent to each household experiencing a decrease in their SNAP benefit based on the recalculation of their case:

- an English/Spanish notice (Attachment B) to active SNAP households;
- an English/Spanish notice (Attachment C) to active Bay State CAP households; and
- a multilingual notice that states, "Important! Please have this notice translated immediately."

#### When to Use New Standards

SNAP cases authorized **after** the close of business on Friday, September 21, 2012 were recalculated using the new COLA standards. Effective Monday, September 24, 2012, the new COLA standards will be used in all automated SNAP calculations. Case managers must be careful to use these standards for any necessary manual calculations.

#### Closed SNAP Households

Retroactive benefits are not owed to closed households because the COLA is effective on the client's cyclical date in October and not on October 1.

#### Eligibility Charts and Issuance Tables

SNAP eligibility charts, issuance tables, standard utility allowance amounts, maximum and minimum benefit amounts, shelter deduction and standard deduction amounts are posted at the <a href="www.mass.gov/dta">www.mass.gov/dta</a> website.

All necessary updates will be made to the relevant SNAP tables at the <a href="https://www.mass.gov/dta">www.mass.gov/dta</a> website by October 1, 2012.
